## Propositions for Craig Voters to Consider on October Ballot

---

**Proposition 1:** TRANSIENT OCCUPANCY TAX  
**Shall the City of Craig, Alaska increase the levy and collect a tax equal to ten dollars per day for occupied hotel rooms?**

Proposition 1 is included on the 2024 Craig Municipal Election Ballot at the request of the Craig City Council. This proposition would increase the existing hotel (bed) tax from \$5 per room per night to \$10 per room per night. The original bed tax was enacted in 2017 and has not been increased since its original enactment. The proposed bed tax is consistent with other bed taxes by municipalities in Alaska. According to the *Lodging Tax Study* published by the American Hotel & Lodging Association in September 2020, the average bed tax for studied communities in Alaska is 8.4% (\$8.40 per \$100 of room charges). This change will generate approximately \$22,000 in additional general fund revenue for the city. If approved, this tax increase would go into effect January 1, 2025. # Propositions for Craig Voters to Consider on October Ballot

- Proposition 2:** SALES TAX RATE  
Shall the City of Craig increase the sales tax from 5% to 7% between April 1 and September 30 and from 5% to 6% between October 1 and March 31 with the additional sales tax revenue generated by the increased sales tax dedicated to funding the Craig City School District?

Proposition 2 is included on the 2024 Craig Municipal Election Ballot at the request of the Craig City Council. This proposition would change the existing 5% year-round sales tax to a seasonal sales tax of 7% in the summer (April 1 – September 30) and 6% in the winter (October 1 – March 31). The purpose of this sales tax increase would be to provide additional general revenue funding dedicated to supporting the Craig School District. This increase is estimated to generate an additional \$750,000 - \$800,000 per year which would be used to help fund the Craig City School District. If approved this sales tax change/increase would go into effect January 1, 2025.

*A statement from the CCSD Superintendent, Jackie Hanson: In October, the City of Craig will see a City/Seasonal Sales Tax Proposal on the ballot, which is in response to the lack of state funding for education. If passed, the additional revenue will provide direct benefit to our kids and the education they receive at Craig City School District. With that said, it's CCSD's hope that our community will pull together on behalf of our children and their education- they are our future and worth our investment.*

- Proposition 3:** INITIATIVE TO REQUIRE VOTER APPROVAL FOR DISPOSAL OF LANDS AT TRACT A, USS 1429  
This ordinance, proposed by initiative, subjects the disposal of any portion of Tract A, USS 1429 as shown on Plat 2009-18, Ketchikan Recording District, to the approval of the qualified voters of the City of Craig. This ordinance applies to any disposal of the subject property where a deed is not recorded prior to the effective date of this ordinance. If this ordinance is approved, it will be effective upon certification of the election.

Proposition 3 is included on the 2024 Craig Municipal Ballot by the voter initiative process. This ordinance, if approved would require voter approval for the disposal of any part of Tract A, USS 1429 (commonly referred to as the “Craig Cannery Property”). This ordinance would apply to all sales of the property where a deed was not recorded with the State of Alaska Recorder’s Office prior to the ordinance’s effective date. If approved, this ordinance would be effective once the 2024 election is certified (scheduled for October 3, 2024). A complete copy of the proposed ordinance is included below.

ORDINANCE No. \_\_\_\_**

SUBJECTING THE DISPOSAL OF CITY OWNED LANDS AT TRACT A, USS 1429, TO APPROVAL OF THE QUALIFIED VOTERS OF THE CITY OF CRAIG

Section 1. Classification. This is a non-code ordinance.

Section 2. Severability. If any provision of this ordinance or its application to any person or circumstance is held invalid, the remainder of the ordinance and the application to other persons or circumstances shall not be affected thereby.

Section 3. Effective Date. This ordinance shall be effective immediately upon certification of the election described in Section 4.

Section 4. Action. This ordinance subjects the disposal of any portion of Tract A, USS 1429 as shown on Plat 2009-18, Ketchikan Recording District, to the approval of the qualified voters of the City of Craig. Approval by a majority of the qualified voters of the City of Craig voting on the matter satisfies the determination required by the Craig Municipal Code 16.03.020.B that the disposal is in the best interest of the City of Craig. This ordinance applies to any disposal of the subject property where a deed is not recorded prior to the effective date of this ordinance.
