RE: Sales Tax Survey Results and Ballot Measure Discussion

A copy of the final survey results are attached for the council's information. There were 164 surveys returned. It was determined that 10 were duplicates and were deleted, leaving 154 surveys total. Among the 154 surveys there were 30 from respondents that indicated that they did not live in Craig. Removing these leaves 124 surveys. This represents a good sampling of Craig voters and should be used to help make some decisions about a ballot measure in October. It is important to note that while the survey turnout was very high, it still only represents about one-half of the likely voters at the October election, so the results are far short of being able to reliably predict the outcome of the October election.

The attached document gives a breakdown of the results. Since the ballot measure must be presented as a yes or no question there are three basic questions that the council needs to consider in order for staff to prepare the ordinance placing an issue on the ballot.

- Does the council want to place a sales tax change/increase measure on the ballot in October 2024?
 - If there is a ballot measure, should the question be based on a flat tax rate increase or a seasonal tax rate increase?
 - If there is a ballot measure, what is the tax rate that the council would like to present?
1. The council is well aware of school district funding issues that are the basis for this discussion. The council is also aware that increased sales tax is the only measure (outside of a large property tax increase) that can generate enough revenue to make a significant impact on the school district deficit in future years. There has also been significant discussion about the time required to enact an increased sales tax.

While there is a one-time increase in state funding in the state budget that has been sent to the governor, there is no guarantee that the governor will not veto some or all of that funding. There is also no guarantee of any additional one-time or formula funding for fiscal year 2026. If a sales tax increase is not considered this year and there is a significant deficit in the school budget next year we may be in the same situation forcing a large draw from the reserve account or significantly cutting school funding. Approval of a sales tax increase on the October ballot is the only means of ensuring a revenue stream that can be used in FY26.

2. Question #4 on the survey asked “If the City of Craig increases sales tax within the municipality, would you prefer to see a flat increase, or an increase based on a higher sales tax rate in the summer?” Nearly 75% of survey respondents indicated that they would prefer a seasonal sales tax over a flat tax increase.

This style of sales tax is becoming increasingly popular for municipalities in Alaska as this reduces the overall tax burden on locals and puts a larger portion of any tax increase on seasonal visitors, seasonal residents, and seasonal workers.

3. The survey asked question #6 “If the city elects to implement a seasonal tax rate that is higher in the summer than the winter, which option and funding level for the school district would you likely support?”

The choices ranged from a model that moved to a seasonal sales tax but did not increase the overall tax revenue to a model that allowed for a nominal 3% increase in sales tax revenue to the city under the seasonal structure.

About 22% of the people that answered this question preferred the 6% Summer/3.5% Winter rate, which did not generate any additional revenue. The results were about the same for each of the next three models and decreased to about 10% at the highest level. Overall, 78% of respondents indicated that they were likely to support some increased revenue on a seasonal sales tax.

At least 55% of the respondents noted that they would support one of the three higher rate options (Summer 6.5%/Winter 5%; Summer 8%/Winter 5.5%; and Summer 8.5%/Winter 6%). These choices would likely generate between \$435,000 and \$1.2 million in revenue. The school district’s request for FY25 was \$1.155 million above the \$550,660 that we have given the past several years.

The council is not tied to these exact models and can make adjustments based on other preferences. For example, if the council wanted to reduce Winter tax rates below the current 5% a model of Summer 8.5%/Winter 4% would generate about \$825,000 in revenue.

Each 1% of summer sales tax will generate about \$290,000 in revenue and each 1% of winter sales tax will generate about \$190,000 in revenue. The council may request calculations on other models. Ultimately, if the council is inclined to move forward with a ballot measure to change/increase sales tax, it should direct staff to work on an ordinance to put the issue on the October 2024 ballot.

The question for the ballot must be a yes/no question, so the council should settle on a single recommendation. The easiest way to choose a tax rate may be to determine the amount of income that the council would like the increase to generate and then looking at the rate models.

While the increased sales tax (if passed by the voters) will not go into effect until the second half of the fiscal year, and the city will need to commit funds to the district based on the council's direction on the local contribution, if the measure passes the city can use additional funds generated in FY24 to provide funding for school capital projects or to bring the school reserve fund balance back up.

Recommendation: Move to direct staff to write an ordinance to place a measure on the October ballot to set the city sales tax at a maximum of ___% in the summer and ___% in the winter, effective January 1, 2025.

OVERVIEW

There were 164 submissions, and 10 of those were found to be duplicates. 30 responses indicated they were not a resident of the City of Craig. The data presented is based on 124 submissions from Craig residents.

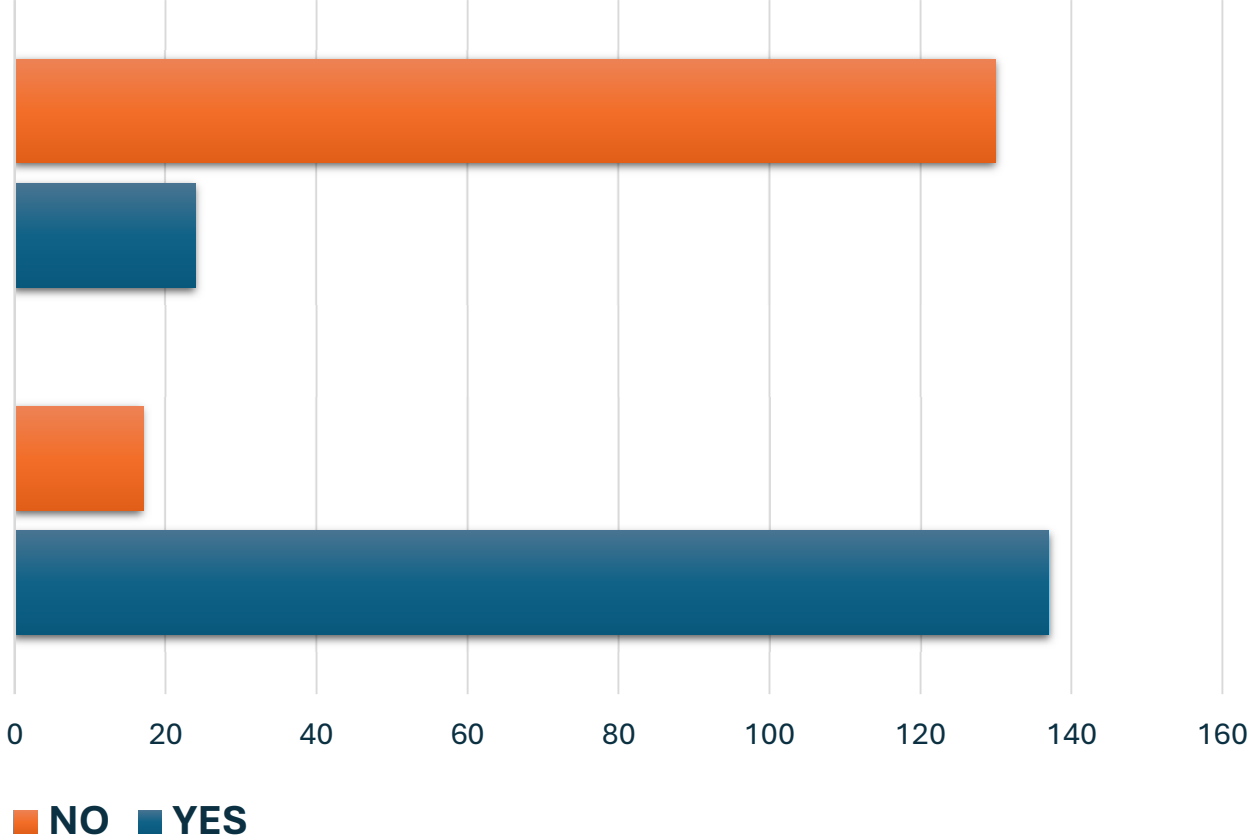
For a flat tax, 38% of responses indicated that they did not want an increase and 62% indicated that they would likely support some increase.

For the seasonal sales tax, 21% indicated that they did not want any increase and 79% indicated that they would likely support some increase.

Do you currently hold a sales tax exemption (i.e. senior sales tax exemption) for Craig City Sales Tax?

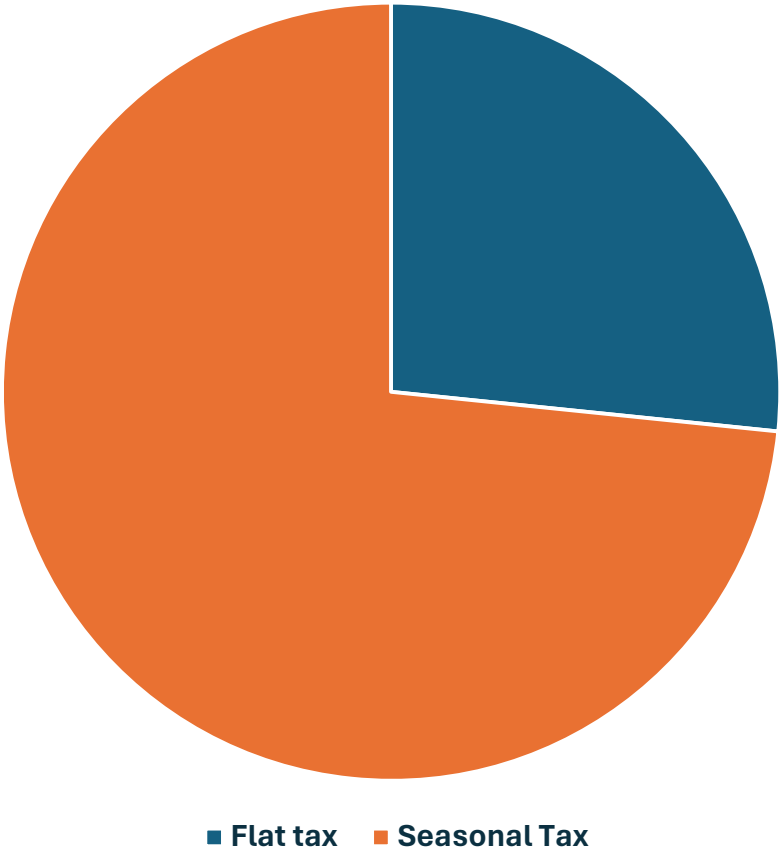
Are you currently a registered voter in the Craig Voting Precinct?



120 participants indicated they are registered voters and 4 are not.

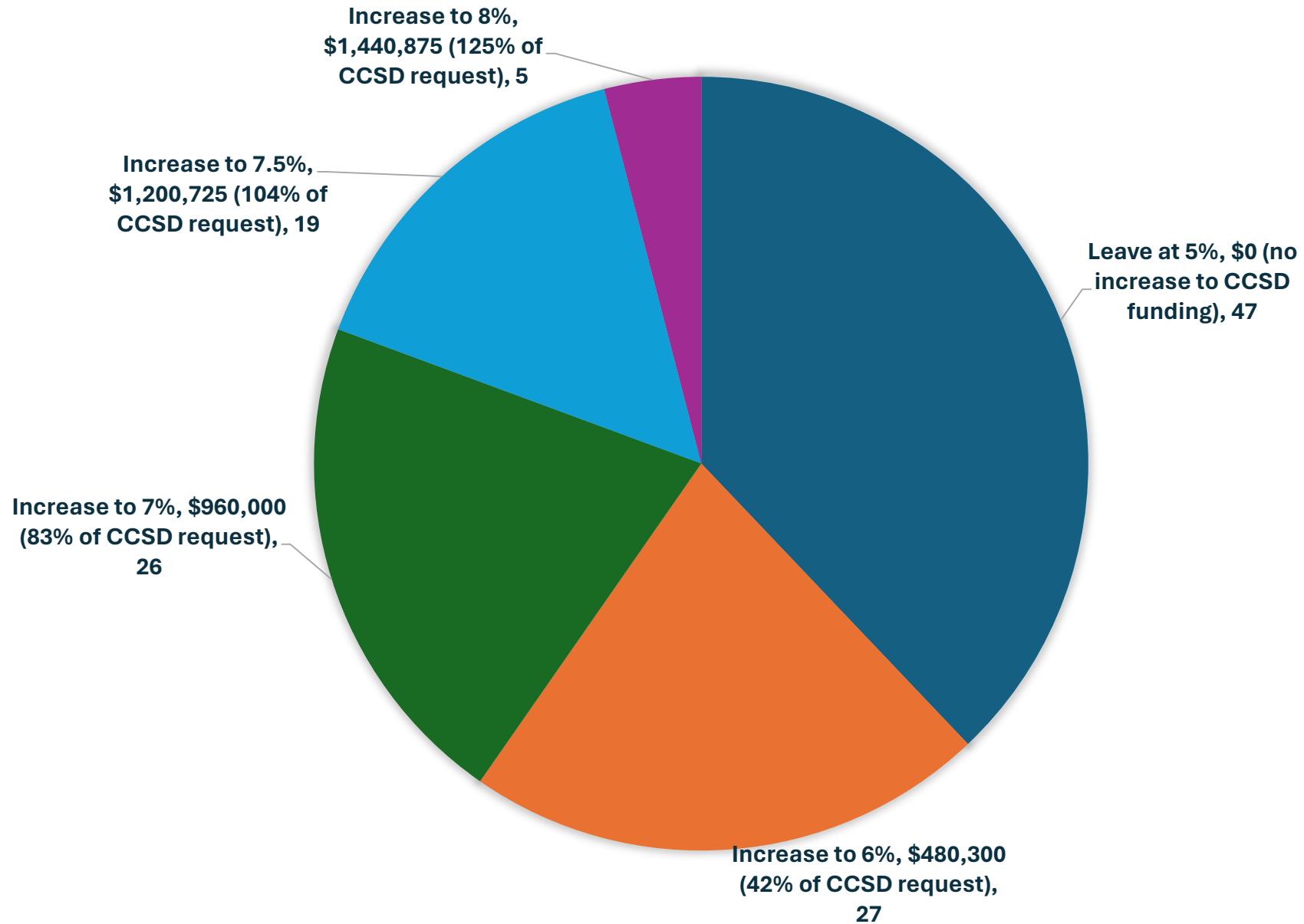
21 participants indicated they have a sales tax exemption for the City of Craig and 103 do not.

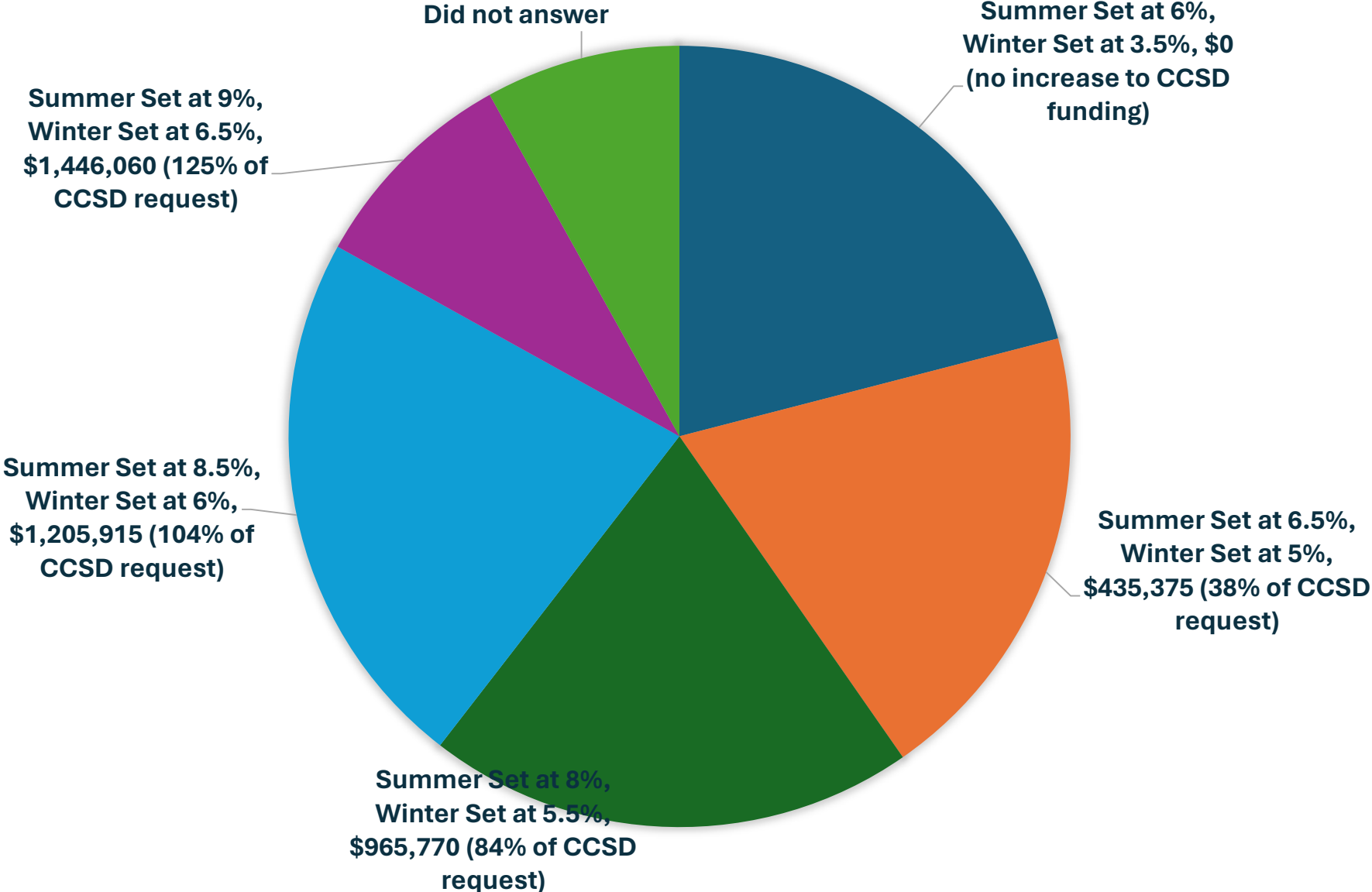


90 participants were in favor of a seasonal tax and 34 participants were in favor of a flat tax increase.

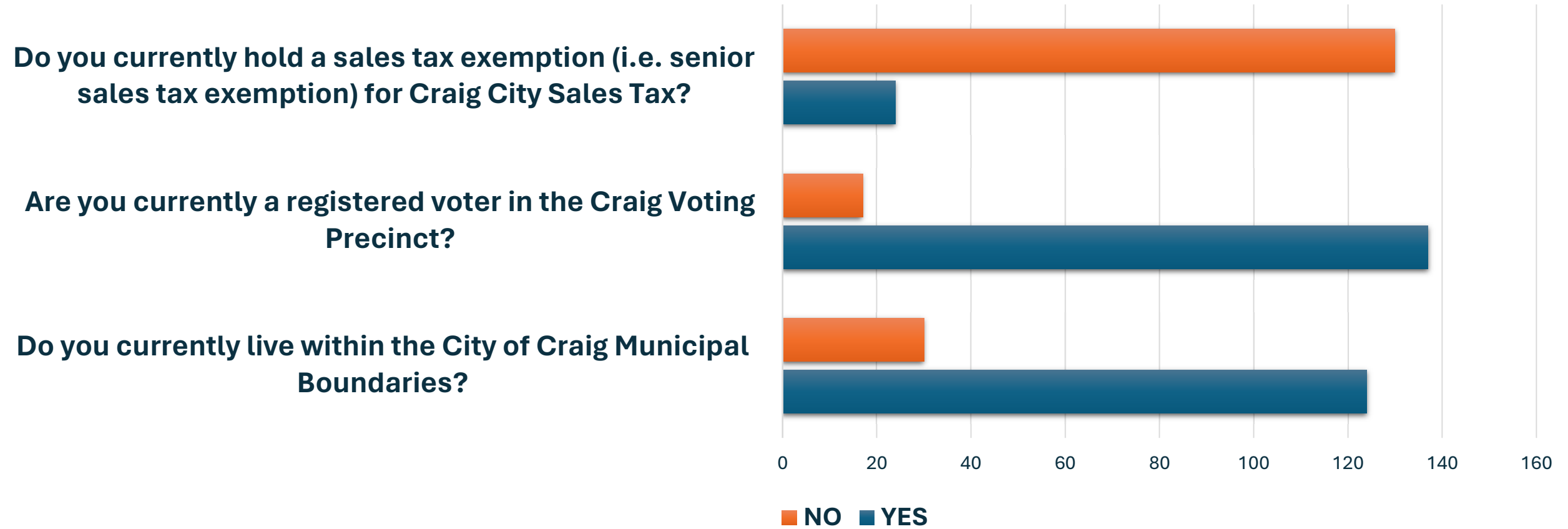
OVERVIEW

There were 164 submissions, and 10 of those were found to be duplicates. The data presented is based on 154 submissions.

For a flat tax, 34% of responses indicated that they did not want an increase and 66% indicated that they would likely support some increase.

For the seasonal sales tax, 20% indicated that they did not want any increase and 80% indicated that they would likely support some increase.

Questions 1-3

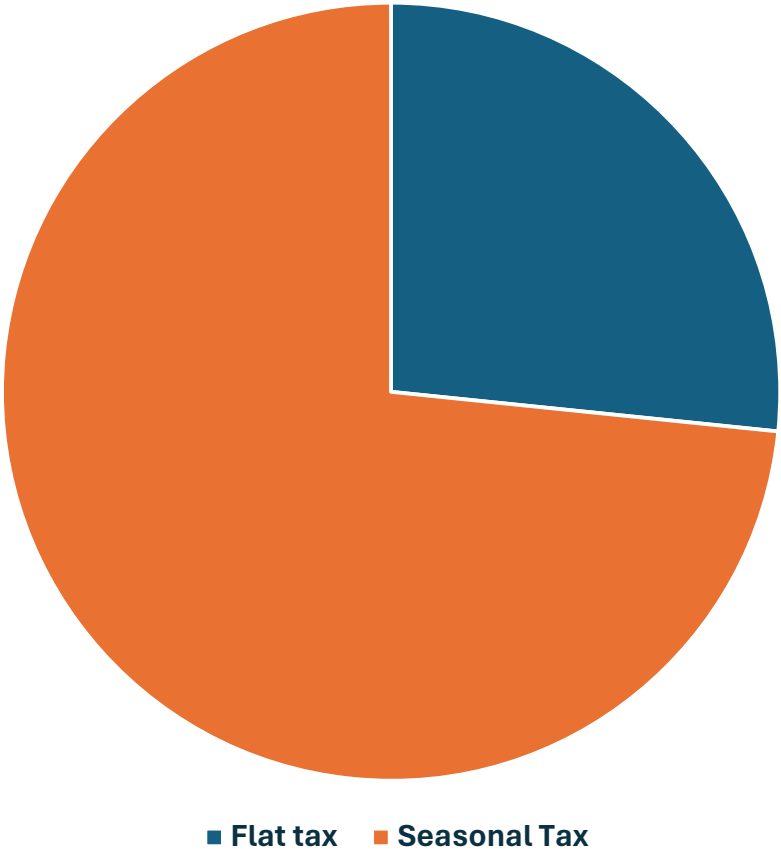


124 participants indicated they live within the City of Craig and 30 do not.

137 participants indicated they are registered voters and 17 are not.

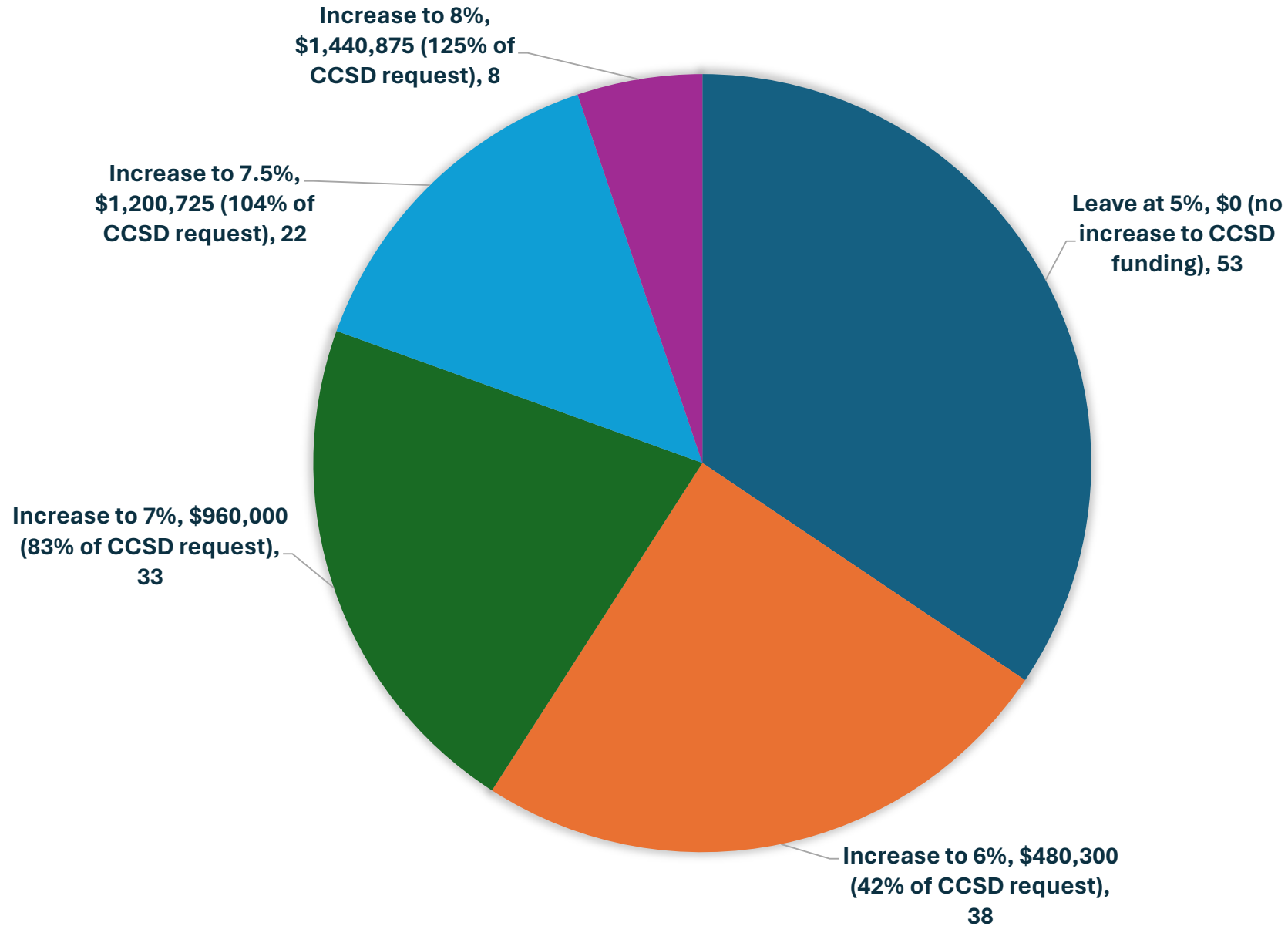
24 participants indicated they have a sales tax exemption for the City of Craig and 130 do not.

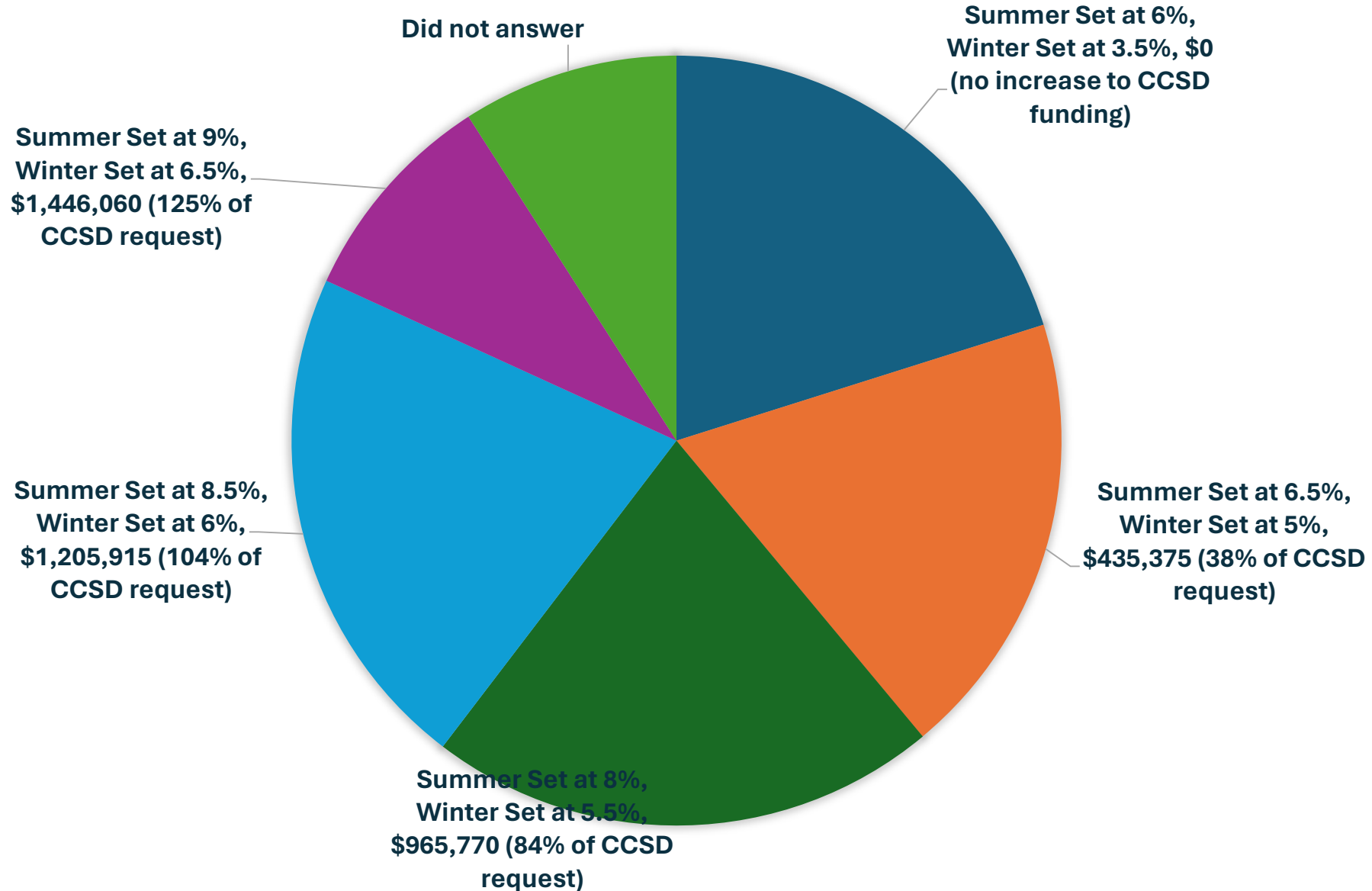


113 participants were in favor of a seasonal tax and 41 participants were in favor of a flat tax increase.

Additional Comments

- This is a tough decision for everyone. I truly hope that there are lots of ideas for EVERY possible avenue to achieve success all the way around! Think everything through thoroughly before deciding! Good luck!!
- Our schools and communities across the state and country are facing very serious budget deficits and as parents and community members it falls on us to do what is best for our future generations and those generations are at risk of losing much needed educational resources. I fully support a tax increase that solely benefits our schools
- The school needs to do better at budgeting like the rest of us do.
- Much of this depends on when and if the state provides additional funding.....If the state leaves it the same, or a minimal boost, the schools need some help, before everything falls apart. Students need education, the community should support education, and the teachers need to feel that they aren't doing this job alone. The kids are our future and we should see that they and the staff are in a safe environment and that the school(s) aren't falling down around them.If the state won't fund , and the governor seems to not care about public education, then the city of Craig should step up and fully fund their part of the education bill....and upping the sales tax will be a good way to bring this about. It is much better than upping our real estate taxes and it spreads the cost among all our citizens and especially among those people who use our resources during the summer and then leave the island.
- This is a hard one. I have friends and family that work for the CCSD. With that said, here is the reality. We are paying 5.40 per gallon for gas at Blackbear (as of this morning), \$50 for a 5lb block of cheese and Shaan Seet just raised their rent by over 10%. Rentals are sky-high and unaffordable. Our work force cannot afford to live here, we are losing workers faster than we can replace them. (It was a problem before Covid and has only exacerbated since) Families are having to make cuts just to live here and work for you, so maybe everyone should have to make cuts as well? Also, how has the CCSD deficit doubled? If they had balanced budgets before Covid, how is it that even after cutting staff/positions their deficit has doubled? Under those balanced budgets, they had more staff/faculty without extra taxes/covid money. Inflation (or whatever you want to call whats happening in SE Alaska) does not account for that. Until CCSD can explain this, I will be advising anyone I know to vote for no increase.
- St Nick should be paying property tax. Bed tax, fish box tax. Other solutions should be included in this besides just increase to the sales tax.

- Hold the administrators accountable for the funds they receive. Your survey didn't give an option for no tax increase! Families must live within a budget and so must those that receive our tax dollars. You can't tax and spend your way out of financial irresponsibility. ALL TAXATION IS THEFT
- As a Craig resident/property owner, and tax payer, It's time to consider consolidation of the four school districts on the island. It's unfair that Craig property owners are on the hook for the funding of the Craig School when there are children from across the island attending the school in

- The seasonal tax rate would be great to have to get some of the tourists and out of state fisherman to help contribute.
- Need to figure something else out. Cost of living in Craig is high enough with the grocery store. And now you want to raise the taxes.
- If the rate does change seasonally. I would recommend making sure the utility company knows so they can update power and telephone bills when the changes happen for summer and winter.
- The school district and city need to do better on budget so we are not in this situation again and plan for the future better..
- I would like to be assured that this tax increase would only benefit CCSD and not any other City related projects.
- 6-7% sales taxes are common most places year-round. I do believe in capitalizing on the increase in population during the summer. I don't know that I support a tax increase on groceries as that could hurt the community.
- Funding our schools should be a priority
- Why should Craig residents pay a seasonal tax?
- City needs to suspend the 4% fuel tax and put it back to 5% to help raise more revenue..
- Thank you for the clear explanation of the current situation, how it came to be, and the potential ramifications if a tax is not passed.
- A BSA increase did pass the state legislature as well as additionally monies for transportation, READS Act, and an increase for correspondence students. Because of these increases Craig School District's needs are less than predicted. School district needs to make some cuts in staffing and tighten up their expenses if our community is

going to pay more sales tax. Residents should be presented with information about what cuts the school district has made in any proposal to increase sales tax.

- Either STOP bussing kids from the entire island to Craig, or get money from elsewhere other than Craig residents. The Craig school wasn't intended to serve the entire island. Or, if it is, then tax everyone in every community. There's kids from every community going to the Craig School!
- This survey is misleading. How about a no tax option. No sales tax, no property tax, keep your greedy hands off my money option?
- Stay with the increased sales tax and not property taxes. I live on Pt St Nick so city property owners would have to carry more of the burden which isn't okay.
- Is there a bus fee for the children that don't live in Craig?
- I do not believe that the school has really cut back on their expenses. I mean they cut "vacant" positions - so those were jobs that were not being paid... where did that money go? The poor financial planning of the school should not become a burden to the Craig residents. If the city does raise sales tax, what guarantee do we have that the school district will use that money any wiser? I believe that they will just continue to ask for more and more money without truly making needed changes to their spending. If they want to save money, why not combine the middle school with the high school (they have an entire second floor that is not being used)? Why was there talk about giving 4% raises to the teachers for the next 3 years? Doesn't the City donate swimming pool hours and handle the heating with the wood boiler system? If there is any increase in the school funding by the city, fund them at the \$800,000 which is the maximum contribution for the city. I am all for supporting the schools, but I feel that an increase in sales tax is just the easy way for the school district to keep spending money foolishly at the cost of the hard working residents of Craig. Everything is more expensive .. not just for the schools but for the rest of us as well. We have all had to make choices about when and how to spend the money we have responsibly. If it is presented in October to raise tax to meet the 800,000 maximum - I will vote yes. If it is to fund them the full 1.3 million, I will vote no.

- We need a gas station in Craig. Can the school benefit from an alcohol or marijuana tax?
- The city holds a reserve fund for the school at Alaska Permanent Capital Management. Consider paying CCSD 4% of the market value of the School Reserve Fund each year.
- "Although I am a senior, I think the exemption for seniors (as well as reduced garbage rates) should be eliminated, or at least establish a means test for them.
- As for the school's finances, it is only going to get worse as enrollment shrinks. I suspect the same is true in Klawock. It is time to put aside our pride and start a discussion about combining into one district with one superintendent, one business office, one high school, one middle school, and maybe two elementary schools."
