A JOINT RESOLUTION BY AND BETWEEN THE COMMUNITIES OF THE PRINCE OF WALES COMMUNITY ADVISORY COUNCIL (POWCAC) SUPPORTING ALTERNATIVE No.1 OF THE 2002 ROADLESS AREA EVLAUATION FOR WILDNERNESS RECOMMENDATIONS DRAFT SEIS

WHEREAS, the Prince of Wales Community Advisory Council acts in an advisory capacity for participating communities on Prince of Wales Island; and,

WHEREAS, the Supplemental Environmental Impact Statement (SEIS) was ordered by the Federal District Court of Alaska when it ruled that the 1997 Forest Plan Revision Final EIS did not include alternatives that considered Wilderness recommendations; and,

WHEREAS, Alternative 1, the No-Action Alternative, is the Preferred Alternative in the Draft SEIS; and,

WHEREAS, the No-Action Alternative is very similar to the 1997 Forest Plan Revision with regard to land use designations, standards and guidelines, which provides a balance of resource protection and utilization within the Tongass National Forest.

NOW, THEREFORE, BE IT RESOLVED that the communities of the Prince of Wales Community Advisory Council hereby recommends adoption of Alternative I of the 2002 Draft SEIS.
