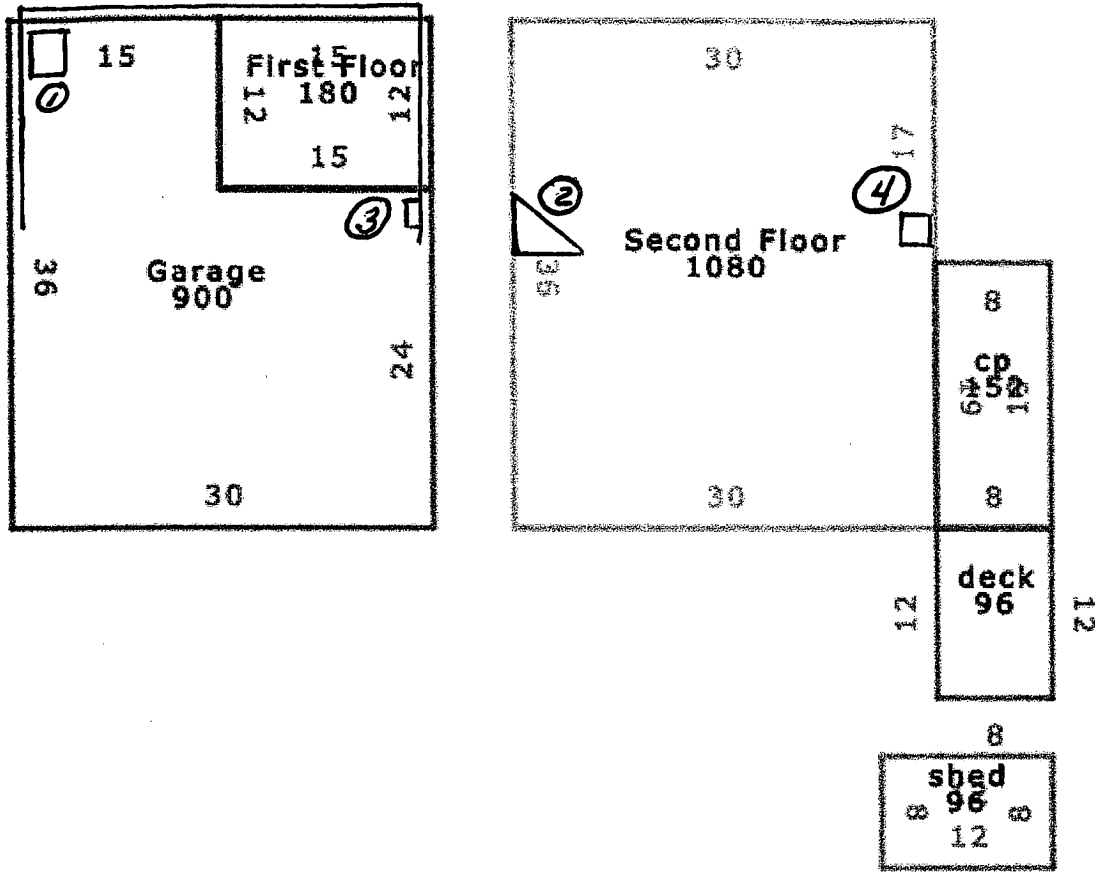
Special Conditions of Approval.
