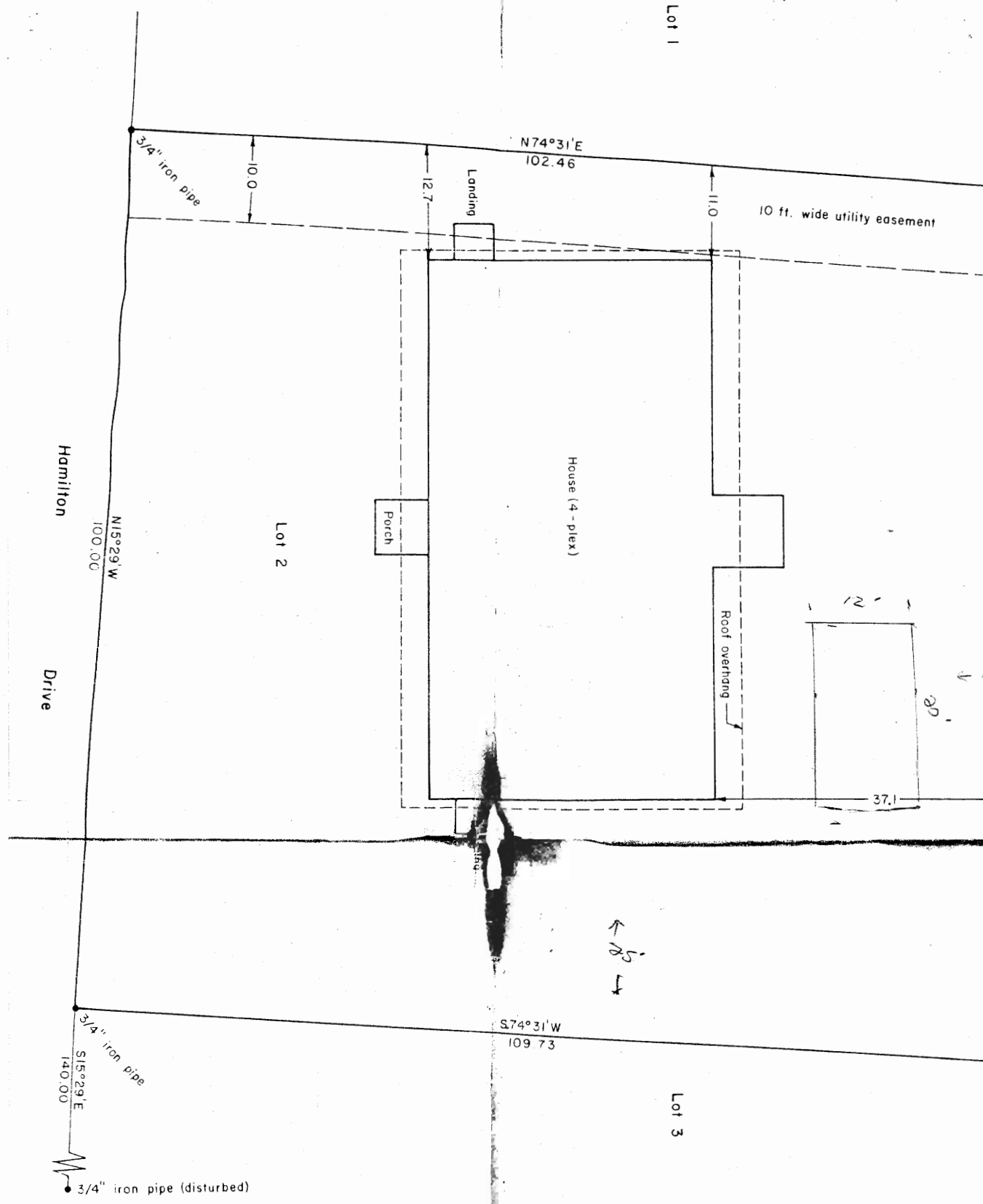
#2. Ensure distance from building meets State Fire Marshal Standards.

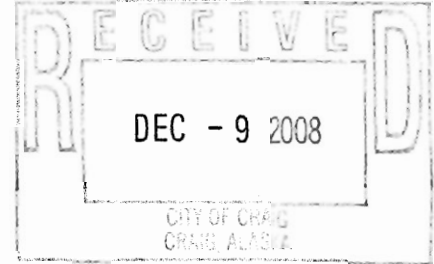
